There is other evidence before me, including your own evidence that, nevertheless, you engaged in a telephone call with one Sharon Catt, whom you knew to be a pending witness in these proceedings. The passage which I have read to you from page 1017 of the transcript, was on 26 February, 2003.

The telephone call to which I have just referred, to which, as I understand the evidence before me, you were a party with a pending witness, was either on 10 or 11 March - certainly after 26 February, when you had been told by me what the conditions of your release were.

I further conclude, from the evidence before me, that you did speak to that pending witness about an aspect of this case and, therefore, that is the basis on which I propose to refer the matter to the Supreme Court; in order to determine whether or not proceedings should be instituted against you for contempt of court. I tell you that so that, if you wish to seek preliminary advice in relation to the matter, you may do so.

Those conditions of your release as a witness still reply, do you understand?
